Victim Wraparound Program

The Victim Services Wraparound Program offers safety planning for victims whose offenders were sentenced under the Youthful Offender Act and are in prison or in the community under intensive supervision. A safety plan is a personalized, practical plan that can help you stay safe and may help to reduce risk of future harm.

Victim Service Liaison

A Victim Service Liaison (VSL) is a victim advocate who works for the SC Department of Corrections (SCDC) with the Division of Victim Services. The VSL can assist you with questions or concerns you may have regarding an offender that was sentenced under the Youthful Offender Act and is currently in prison or in the community under Intensive Supervision. The VSL can also assist with developing a personalized safety plan and may also provide community referrals and resources.

Victim Wraparound

A Victim Wraparound is a safety planning meeting that brings together the victim, their support person(s), the VSL, the Intensive Supervision Officer (ISO) and relevant community partners in a collaborative effort to develop a personalized safety plan for the victim and his/her family. The VSL facilitates this meeting at the request of the victim.

SC VINE

The SC Department of Corrections partners with the South Carolina Victim Information and Notification Everyday (SC VINE) system. Registered victims may receive automated phone calls, e-mails or text messages, in English or Spanish, of the release, escape or transfer of an offender. Release notifications will be provided in advance of the offender's release and the same day the offender releases from custody. You may also obtain the offender's location and projected release dates by calling the SC VINE system, toll-free, at 1-866-727-2846 or you may go to www.vinelink.com. This service is available 24 hours a day, 7 days a week.

It is imperative that you keep your contact information updated with the Division of Victim Services in order to receive timely information.

Unwanted Contact

If you have been threatened or are in immediate danger, call 911 first.

If you receive unwanted contact from an offender, or from anyone on behalf of an offender, please contact the Division of Victim Services at 1-800-835-0304. We will assist in taking measures to stop the contact. Intensive Supervision Services (ISS) is an After Care Program that utilizes evidencebased practices to assist in the reduction of recidivism, improved family and individual functioning, and the promotion of public safety.

Youthful offenders have conditions of supervision. These conditions are guided by public-safety considerations and engage each offender in programs to promote community safety, reduce victimization and ensure the successful reentry of young offenders back into the community.

Through ISS, an Intensive Supervision Officer (ISO) works in the community and is assigned to each Youthful Offender. The ISO acts as a case manager and offenders report to ISOs on a weekly basis. Depending upon the offender's history or crime, the offender may be prohibited from having contact with minors or specific victims. They may also be required to submit to urinalysis testing, participate in substance abuse treatment programs, be placed on home electronic monitoring or have movement and/or residential housing restrictions. A range of sanctions may be imposed for non-compliance, up to and including additional jail time.

Often times, the VSL works hand-in-hand with ISO's to promote both victim and public safety. If you have any safety concerns regarding an offender, it is important that you let us know by calling Victim Services at 1-800-835-0304.
